What is the Medical–Legal Partnership for Seniors–Veterans Project (MLPS–V)?

The MLPS–V is a new law clinic for patients of the San Francisco VA Medical Center who are seen through the Geriatric and Palliative Care Clinics.

Geriatric and Palliative Care patients can get a free consultation with a legal advocate and, in some cases, free representation.



What kinds of legal issues can MLPS–V help me with?

MLPS–V advocates may be able to help draft your advance planning documents such as your:

- Advance Health Care Directive
- Durable Power of Attorney
- Simple Will

You can also get referrals or legal advice about issues such as:

- Medi–Cal or Medicare
- In–Home Supportive Services
- Elder Abuse
- Other Issues

Who is eligible for MLPS–V Services?

- Patients of the San Francisco VA Medical Center Geriatric Clinic
- Patients of the San Francisco VA Medical Center Palliative Care Clinic

How much do MLPS–V Services Cost?

Nothing. MLPS–V Services are free.
